1. EXECUTIVE SUMMARY

How has urban mobility changed in recent years? How will cities adapt to the new safe, sustainable and connected mobility? These questions must be answered by leaders of public administrations around the world.

In the new era of mobility, the main players are the people, who nowadays have a wide range of options within the transport systems to get around. Pedestrians and public transport play a leading role, while other individual modes of travel take on an increasingly important role, such as bicycles or PMDs.

The greatest challenge that society faces in the field of urban road safety is to guarantee the safety of all road users, especially the most vulnerable ones. It is interesting to know how different countries are addressing PMD mobility regulation. For this reason, a questionnaire was sent to the High Level Group members of the European Commission in May 2021, the findings of which are set out in this report. The following countries have taken part on it: Austria, Belgium, Bulgaria, Denmark, Finland, France, Germany, Greece, Hungary, Ireland, Italy, Lithuania, Luxembourg, Netherlands, Norway, Slovakia, Slovenia and Spain.


Key findings

- Two categories of vehicles were studied: e-scooters and those of L1e-B category (two-wheel moped), as defined in the EU regulation. With regard to the latter, from the responses received, we noted that there may not be a clear understanding of the types of vehicles that could be included in this category.
- Almost every single country has opposite regulations concerning license plates, vehicle registration, insurance, trainings, minimum age and helmet use in both categories.
- Despite the lack of some clear answers, L1e-B are widely regulated while e-scooters still have a lot of room for improvement. The situation in the near future is likely to be the same because there are no countries where deep changes are foreseen.
- E-scooter and L1e-B users do not have the option to voluntary register their vehicles in their countries, with the exception of e-scooters in Lithuania.
- Only in Italy the applicable regulations depend on the use made of the vehicle (personal use, sharing, parcel delivery ...), when talking about e-scooters.
- Luxembourg has the lowest minimum age to drive an e-scooter with a 10 years old limit for all categories. The highest limit is set in Denmark and Slovakia for e-scooters with a limit of 15 years old. Concerning L1e-B vehicles the highest one is 18 years old, which is set in Lithuania, while the lowest is 14 in France, Hungary, Italy and Slovenia.
- Regarding vehicle insurance, the situation is quite different for e-scooters and L1e-B vehicles. Voluntary insurance is most common for e-scooter vehicles, with the exception of France and Germany where it is mandatory. On the other hand, insurance is mandatory for L1e-B vehicles everywhere but in Belgium, Bulgaria and Norway.
- A mandatory driving license for PMDs is usually set for L1e-B vehicles, but it is not the same with e-scooters where voluntary trainings take the lead as in Austria, Belgium, France, Lithuania, Norway and Spain.

- Wearing a helmet when using an e-scooter is only mandatory in Austria, Bulgaria, Greece, Italy and Slovenia, while L1e-B users must wear helmet almost everywhere, with the exceptions of Austria and Netherlands.
